**REGULAR MEETING at City Hall
Petersburg, Illinois**

I. CALL TO ORDER

Mayor Pro Tem Andrew Gain called the City Council to order at 7:00 p.m.

2. Water Superintendent Dave Troxell gave the Water Superintendents Report. Discussion on the Water Tower Radios. Replacing all 4 radios, antennas and cables would be about \$38,000.
3. Discussion of the Becker Street water extension. Discussion with Jeff Broughton about extending the lake water line 2500 feet down Becker Street. A motion made by Alderman Gain seconded by Alderman Gorman to approve to move forward with the price agreement and contracts for the construction of the Becker Street extension with George Becker. 4. Discussion on Water Sewer Project for East Bluff. Dale Vanetten owns land just East of his home and wants to divide into 6 lots and would like sewer and water to the site. A motion made by Alderman Gorman Seconded by Alderman Sonnemaker to move forward with a contract to install the East Bluff Water/Sewer Project.
